RELEASE AND WAIVER AGREEMENT

Under 18 Years of Age

In consideration of being allowed to participate on the Xtreme Xpo at River Valley Ranch for **SATURDAY & SUNDAY, APRIL 28 & 29, 2007** I, for myself and any minor children for whom I am parent, legal guardian, or otherwise responsible and for my/our heirs, personal representatives or assigns, hereby acknowledge the risks of injury or damage (to property, personal injury and/or death) involved in **SKATEBOARDING** on the 3 skateparks. I understand that there is inherent danger in riding skateboards that we each appreciate and voluntarily assume because the minor and we choose to do so. I further agree to require said minor to read the skatepark rules posted at the site and to participate in all safety training and wear all necessary safety equipment (minimum of a helmet) while participating the above activities.

I, for myself and any minor children for whom I am parent, legal guardian, or otherwise responsible and for my/our heirs, personal representatives or assigns, hereby acknowledge the risks of injury or damage (to property, personal injury and/or death) involved in **PAINTBALL, THE CLIMBING TOWER/WALL, GO CARTS, AND MOUNTAIN BOARDING**. I understand that there is inherent danger in these activities that we each appreciate and voluntarily assume because the minor and we choose to do so. I further agree to require said minor to participate in the safety training before each activity and wear all required safety equipment while participating in the above activities.

I, for myself and any minor children for whom I am parent, legal guardian, or otherwise responsible, hereby release, acquit and forgive River Valley Ranch, L.L.C., its principals, directors, officers, agents, employees, volunteers and its owner, Peter and John Radio Fellowship, Inc. ("Releases") from any and all liability of any nature for any and all injury or damage (including property damage, personal injury, illness, blindness, paralysis, and/or death) to me or said minor children as the result or my/our participation in the Xtreme Xpo at River Valley Ranch including skateboarding, paintball, the climbing tower and mountain boarding.

I, for myself and any minor children for whom I am parent, legal guardian or otherwise responsible, and for my/our heirs, personal representatives or assigns, also hereby expressly waive any claim, lawsuit, complaint, charge, or cause of action against River Valley Ranch, L.L.C, Inc. its principals, directors, agents, employees and its owner, Peter and John Radio Fellowship, Inc. and for any and all injury or damage, to me or any such minor children and other persons as a result of my/our participation in the Xtreme Xpo at River Valley Ranch including skateboarding, paintball, climbing tower and mountain boarding.

I, for my/our heirs, personal representatives and assigns also hereby expressly agree to indemnify and hold harmless River Valley Ranch, L.L.C, Inc. its principals, directors, employees, and its owner, Peter and John Radio Fellowship, Inc. including costs, expenses and counsel fees, from and against all claims, lawsuits, complaints, charges or causes of action arising from the participation in the Xtreme Xpo at River Valley Ranch, and the activities for which this Release and Waiver Agreement is given.
