

# RIVER VALLEY RANCH RELEASE AND WAIVER AGREEMENT

I acknowledge and accept that there are significant elements of risk in any adventure, sport, activity or training associated with horseback riding, rodeo activities, paintball, climbing wall, alpine tower, ropes course, whitewater rafting, canoeing, activities involving hiking, climbing, and rappelling that require harnesses, belays and other safety equipment, skateboarding, mountain boarding, go-karting and other camp activities (referred to herein as "activities"), and the use of any equipment. Activities may include, but are not limited to: horseback riding, riding of and interacting with live rodeo animals, canoeing, whitewater rafting, paintball, swimming, low and high ropes course elements, climbing tower, alpine tower, zip line, giant swing, hiking, climbing, rappelling, skateboarding, mountain boarding and go-karting.

In consideration of being allowed to participate in the camp program at River Valley Ranch for the week of **(dates)** \_\_\_\_\_ I, for myself and any minor children for whom I am parent, legal guardian, or otherwise responsible and for my/our heirs, personal representatives or assigns, hereby acknowledge the risks of injury or damage (to property, personal injury and/or death) involved in participating in the activities at River Valley Ranch. I further agree to require said minor to participate in all safety training and wear all safety equipment provided by River Valley Ranch for any of the above activities. I further understand that at times horses and live rodeo animals can be unpredictable and that there is inherent danger in the riding of and interacting with these animals that we each appreciate and voluntarily assume because the minor and we choose to do so. With regards to the Adventure Plus camp, I agree to allow my child to take camp transportation to participate in some of the above-related activities off of River Valley Ranch property.

I, for myself and any minor children for whom I am parent, legal guardian, or otherwise responsible, hereby release, acquit and forgive Peter & John Radio Fellowship, Inc. and River Valley Ranch, L.L.C., its principals, directors, officers, agents, employees, and volunteers ("Releases") from any and all liability of any nature for any and all injury or damage (including property damage, personal injury, illness, blindness, paralysis, and/or death) to me or said minor children as the result of my/our participation in the River Valley Ranch summer camp program.

I, for myself and any minor children for whom I am parent, legal guardian or otherwise responsible, and for my/our heirs, personal representatives or assigns, also hereby expressly waive any claim, lawsuit, complaint, charge, or cause of action against Peter & John Radio Fellowship, Inc. and River Valley Ranch, L.L.C., its principals, directors, agents, employees and for any and all injury or damage, to me or any such minor children and other persons as a result of my/our participation in the River Valley Ranch summer camp program.

I, for my/our heirs, personal representatives and assigns also hereby expressly agree to indemnify and hold harmless Peter & John Radio Fellowship, Inc. and River Valley Ranch, L.L.C., its principals, directors, and employees, including costs, expenses and counsel fees, from and against all claims, lawsuits, complaints, charges or causes of action arising from the participation in the River Valley Ranch summer camp program.

I also give my permission for the applicant to participate in all activities as they pertain to his/her program. I authorize River Valley Ranch to hereby use any pictures or video for promotional use.

I authorize the person listed on the application as "Name of Person Picking Up Camper" to pick up my child from camp or one of the designated drop-off locations.
